1. Dan Colquhoun motioned to pass Amended minutes from the May 2016 meeting. Deb Moran seconded, all were in favour. Motion carried.

- 2. Chatter from the Chairs Tricia and Michael
 - 2.1. Motion to pass regulation discussed at May Meeting,

If Board Of Management members miss 3 meetings in a row a year they will no longer be part of the BOM.

Discussion: Everyone agreed that something needed to be done about members not fulfilling their responsibilities of attending meetings. There will be emergencies come up, vacations etc. that are not questioned, but not letting the Chairs know you are going to be away is a sign of disrespect that needs to be addressed.

Jeff Roy motioned that after 2 missed meetings in a row, the member will be contacted to see if they have plans of continuing on the Board of Management. If they then miss a third meeting in a row, they will be taken off the BOM. Rosalyn McFarlan seconded, all were in favour. Motion carried.

Presentation by Angela Smith: Angela shared some of what she presented to the hiring committee. Design ideas for Spooners Lane since Brenda McIsaac does weddings at Town Hall...set up chairs for the ceremony or have 4 tables with umbrellas that would allow a wedding dinner, or a Beer tasting night....Artists Alley is another idea, no cost as artist supplies everything, and it encourages street traffic.

Vacant Lot ideas – Angela used her photography talent to show overlays of a Bandshell, seating and rock area for the vacant lot. Angela has volunteered for events held in Central Huron, currently works on Payroll for the Municipality and once her position is filled, will be taking on more projects for us.

Chain of Command for Angela's time is through the Steering committee. Mayor Jim Ginn, CAO Steve Doherty will facilitate Angela's time. BIA Chairs will bring our ideas to Steering committee that same Friday of our BOM meeting. Our job priority list - Social media is her biggest commitment for BIA....Associate member campaign could be put to the back burner for now... Promotions committee can be assisted as Angela is willing to attend committee meetings. Potential jobs that come up from the meeting for Angela must be requested through the Chairs to the CAO.

Jeff Roy would like to see Angela on the Branding committee

that was voted down in Council last year. Dan Colquhoun suggested Chairs bring this idea to the steering committee, invite Council to send 4 members, 4 BIA members and Angela.

BIA members will be Jeff Roy, Darlene Hymers, Roz McFarlan and Michael Russo

Jeff wants to know who is evaluating Angela's job as the time goes on....CAO Steve and the Mayor - Jeff would like to keep it on track with proper channels so we don't lose ground again.

3. Presentation from Tom Williscraft at CKNX Radio on advertising

Ask Central Huron to share in advertising throughout year. We have budgeted for advertising over and above of special events happening in town.

Marketing objectives offered from Blackburn would be easy to execute, we want to draw more community to Clinton.

CKNX will partner with us to help provide a full year of advertising on 3 stations. \$100 per month for 18 business participating. A variety of ways to do ads..

60 sec. ad, BIA 15 sec. 3 other business 15 sec. each... 10 per month Tom sells the ads...

Possibly change up ads every month
